911 COORDINATOR REPORT

PSAP UPDATE

- Call numbers were presented this month.
- We are fully staffed with full-time but are still down with part-time. We have a good group of people that are trying very hard. Jason explained it was a union issue and should be discussed more next week. The argument is due to how many hours are compensated.
- Jason went to Cass County to review their set up as our back up. It need fine tuned and Jason will speak with GTSI about switching channels and correcting Starcom. He will get a quote from GTSI on clean up and get rid of entities that are not in play such as Greenview BLS, Fancy Prairie, and Oakford BLS. They have one dispatcher on duty but we will send someone if needed as they do have equipment for them to use. John talked with Chris and they are concerned that it could go down at any time.

- By law we have to have sexual assault training and it is on line. This course takes 6 hours.
- National Q will have training as we are at 60% compliant. This new trainer is better than previously.
- Mapping proposal on Cushing is at a total price of \$22,500.00 with an annual maintenance fee of \$1,500.00. Central Tri- State we have not received a quote. We are tabling for now until we have a full board. This needs to be completed by December 31st.
- Jason feels everything is OK for now. We are not behind on any updates/versions and Tom Doyle has assisted with this.
- Dave King questions why we are not getting pager checks on schedule. It was decided they will be on Sundays at 6:00 p.m.
