Once this is received we will have a meeting with all to explain how the maintenance fees, budget, expenditures, and how it works in the breakdown of charges versus costs. John will get this together as soon as possible and set the meeting up.
- We still have two outstanding software maintenance fees.
- John received two invoices from GTSI. One was the doors at the jail and remaining one was on Starcom renaming on console. John will ask Ben Hollis on this.
- We still have errors on the main database due to the addressing on the annex that Petersburg initiated a few years ago. This will need corrected out east of Petersburg. Those residents will need to be the standard for 911 which is the 5 digit mark. We still do not have the addresses yet on what it will be going to whether city or county. We should do it all together at once so we will table for now. John will gather the documentation from 2014 and will send to the residents on how this all came about.
