The following Special Provision supplement the "Standard Specifications for Road and Bridge Construction", adopted

January 1, 2022

, the latest edition of the "Manual on Uniform Traffic Control Devices for Streets and Highways", and the "Manual of Test Procedures of Materials" in effect on the date of invitation of bids, and the Supplemental Specification and Recurring Special Provisions indicated on the Check Sheet included here in which apply to and govern the construction of the above named section, and in case of conflict with any parts, or parts of said Specifications, the said Special Provisions shall take precedence and shall govern.

NOTICE TO ALL BIDDERS:

Please mark the outside of the bid envelopes "2023 General Bituminous Letting, Menard County".

The materials to be purchased as a result of this letting are for the use of Menard County to accomplish their 2023 construction and maintenance programs. Pre-qualification of bidders shall NOT apply to this proposal.

A BID BOND will NOT be accepted for the proposal guaranty.

The bidder has to option of bidding any or all of the groups. The award will be made to the lowest responsible bidder for each group. The bidder may submit one proposal guaranty covering the total of the entire groups bid rather than a proposal guaranty for each group bid.

The successful bidder shall have the option of substituting a surety bond for the full amount of the award for his proposal guaranty or reducing the proposal guaranty to cover all those groups for which the bidder was low bidder.

All, part, or none of any group may be purchased. The County reserves the right to increase or decrease the quantity of materials. No allowance will be made in the unit price bid for any increase or decrease in quantities. The unit prices bid shall remain firm until December 31, 2023.

Deliveries over 150 miles shall not be acceptable. Bidders shall designate the point from which shipments will be made.

The successful bidder shall provide a minimum of three (3) hours free time, after delivery to the designated site or from the time the load is due which ever is later, to unload the bituminous materials. If material is not unloaded within three hours, the County will pay a demurrage at the rate of one hundred twenty-five dollars (\$125.00) per hour not to exceed a total of six (6) hours for each transport load. The successful bidder will pay any demurrage charged by the carrier. The successful bidder in accordance with this special provision will bill the County. This cost is to be included in the unit price bid.

All "checks" and bank drafts shall be made payable to the Menard County Treasurer. The unsuccessful bidder(s) "checks" or bank drafts shall be returned at the time of the award.

The successful bidder(s) "check" or bank draft shall be held to insure prompt and faithful performance of the provisions of this agreement. The same shall be returned to the successful bidder(s) after satisfactory delivery of the materials has been made.

Failure on the part of the successful bidder(s) to make satisfactory delivery of the materials within 10 days from the date of the notice to ship the materials will be considered as just cause for the forfeiture of the "check" or bank draft to the Menard County Treasurer.

The successful bidder(s) may substitute a surety bond for the full amount of the award in lieu of the proposal guarantee after award and with the approval of the Menard County Board of Commissioners.

TERMINATION OF CONTRACT:

It is understood that this agreement shall terminate on December 31, 2023.

SUPPLIERS COMMITMENT

Any bidder who does not furnish the Bituminous Materials or Seal Coat Aggregate from their own plant or quarry shall supply a commitment from a supplier that will furnish that material to the bidder. The commitment is for quantity of material only--price is between the bidder and the supplier. The quantity of material covered in the commitment shall be the quantity bid for each type of material plus 50% for possible overrun. This commitment is to be submitted with the bid. NO BID WILL BE READ IF IT IS NOT ENCLOSED.

SPECIAL PROVISION

BITUMINOUS MATERIALS

Revise Article 1032.02 of the Standard Specifications to read:

Measurement of Volume. Measurement of the volume of asphalt binders, emulsified asphalts, rapid curing liquid asphalt, medium curing liquid asphalts, slow curing liquid asphalts, asphalt fillers, and road oils will be based on the volume of the material at 60 °F (15.6 °C). Volumes measured at higher or lower temperatures will be corrected to the volume at 60 °F (15.6 °C) using the Standard ASTM-IP Petroleum Measurement Tables, ASTM D 1250.

Payment will not be made for bituminous materials in excess of 105 percent of the amount specified by the Engineer.

When bituminous materials are delivered by tank truck from a refinery or from a storage tank, a weight ticket for each truck load shall be furnished to the inspector. The ticket shall show the weight of the empty truck (the truck being weighed each time before it is loaded), the weight of the loaded truck, and the net weight of the bituminous material. If the material is being measured for payment by the gallon (liter), the specific gravity at 60 °F/60 °F (15.6 °C/15.6 °C) of the bituminous material in the tank truck and the number of gallons (liters) at 60 °F (15.6 °C) shall be shown on the weight ticket.

Basis of Payment Group No. 1. This work will be paid for at the contract unit price per GALLON for SEALING GRADE ASPHALT BITUMINOUS MATERIALS (Seal Coat) (Furnished), delivered "FOB Distributor Job Site" at various locations throughout the county, and no additional compensation will be made.

Basis of Payment Group No. 2. This work will be paid for at the contract unit price per GALLON for MIXING GRADE ASPHALT BITUMINOUS MATERIALS (Seal Coat) (Furnished), delivered "FOB County Yard" and no additional compensation will be made.
