Russ Bassett's quote that Ben approves is estimated at \$38,796.87. Hanson and GTSI will be in charge of removal of computer equipment and re-installing once the new furniture is in place at an estimation of another \$3,000 to \$5,000.00. A motion to go with the Russ Bassett's quote of \$38,796.87 was made by Ron Cooley and seconded by Jason Huffman. All aye. Motion carried unanimously.
