Clerk Gum requested approval of FY22 Intergovernmental Agreement with Sangamon County for the Provision of Public Health Services. Commissioner Cummings moved to approve the agreement. Commissioner Brauer seconded the motion. The motion carried with four 'ayes', no 'nays', and one absent.

County Clerk Gum presented the Auditor's Letter of Understanding and Engagement. Letter for Non-Audit Services. Commissioner Whitcomb moved to approve the Auditor's Letter of Understanding and Engagement. Commissioner Cummings seconded the motion. The motion carried with four 'ayes', no 'nays', and one absent.

State's Attorney Grosboll reported that Judge Atterberry received grant money for updating the electronics in the courtroom allowing for zoom hearings.
